WHAT IS CIVIL LEGAL AID?



• Civil Legal Aid is free legal assistance to low and middle-income people, families, and communities who have (non-criminal) civil legal problems.

How can Civil Legal Aid help me?



Civil Legal Aid can support with legal assistance in the following subject matter areas: domestic violence, family law, child custody, governmental assistance and services, health care, housing and utilities, landlord/tenant issues, social security, mortgage foreclosures, consumer, financial services, credit, and bankruptcy, employment, rights of residents of long-term care facilities, wills, estates, and living wills, elder abuse, guardianship, disability rights, education, including special education, administrative agency decisions, and discrimination.

How can Civil Legal Aid help me with my workplace issues?



Some scenarios of when Civil Legal Aid can support with legal assistance: Wage theft (not paying minimum wage; not paying overtime; not allowing breaks; stealing tips).
Harassment, discrimination, and/or retaliation (about your gender identity or sexual orientation; race; or in response to a complaint you made about working conditions).
Health and safety (trip, slip, and fall; exposure to pesticides or other chemicals; electricity hazards). Sick leave (denial of sick leave; punishment for taking leave).

CIVIL LEGAL AID AND IMMIGRATION STATUS

Can I access Civil Legal Aid if I am undocumented?



Yes. Some Civil Legal Aid organizations receive federal funding which prohibits them from representing some undocumented persons. However, there are many exceptions to this (for example, if you are elderly or disabled). No matter what your immigration status is, the organization can still provide legal information and can refer you to an attorney, even if representation is prohibited.** This should not prevent you from seeking assistance. All Volunteer Lawyer Programs can assist undocumented individuals.



Can a Civil Legal Aid attorney help me adjust my immigration status?

• Most Civil Legal Aid organizations do not have immigration attorneys on staff. They can refer you to a Civil Legal Aid organization that specializes in immigration law, but keep in mind the waiting lists are long and access to free immigration legal services is very limited in Washington state. They may also be able to refer you to a private attorney. Some free citizenship clinics may be available.

WHAT IS A CIVIL LEGAL AID CLINIC?





- What is the difference between a consultation and representation?
- A consultation or a clinic is a one-time, typically 30-minute, conversation with an attorney, free of charge. Representation means the attorney has agreed to take your case and represent you in court. Many times civil legal issues are resolved outside of court with the Civil Legal Aid attorney serving as the mediator and assisting you with settling the case.



Will I be asked about my immigration status?

• The staff-person at the organization or the attorney may be required to ask about your citizenship status to help determine what services you may be eligible for. This information is often required for funding purposes only, strictly confidential and will never be shared without your consent.



I am undocumented, if my case goes to court, is it safe for me to engage in a civil legal proceeding?

• In civil proceedings, court rules preclude raising immigration status. In Washington, the Courts Open to All Act prevents arrests at the courthouse (or within a mile of any courthouse) for immigration violations.

Is it safe to interact with a Civil Legal Aid attorney, is my information private?

• Civil Legal Aid organizations and volunteer lawyer programs will not report your immigration status to anyone. Your interactions with an attorney are all confidential. Attorneys have a duty to keep client confidences. This is also called attorney client privilege.
