YOU HAVE THE RIGHT NOT TO OPEN THE DOOR



COMMUNICATE THROUGH A WINDOW OR CLOSED DOOR.

ICE AND CBP AGENTS CAN ONLY ENTER YOUR HOME EITHER WITH YOUR CONSENT OR WITH A SEARCH WARRANT ISSUED BY A COURT AND SIGNED BY A JUDGE OR MAGISTRATE. (SEE BACK FOR EXAMPLE.)



YOU HAVE THE RIGHT TO REMAIN SILENT & NOT TO SIGN ANY DOCUMENT

YOU CAN SAY OUT LOUD THAT **YOU WILL NOT ANSWER QUESTIONS**OR SIGN A DOCUMENT WITHOUT AN ATTORNEY PRESENT.



YOU HAVE THE RIGHT NOT TO CONSENT TO A WARRANTLESS SEARCH

YOU HAVE THE RIGHT TO REFUSE THE AGENTS ENTRY TO YOUR HOME. AND YOU HAVE A RIGHT TO REFUSE WARRANTLESS SEARCHES OF YOUR BODY, YOUR CAR, OR YOUR HOME.



YOU HAVE THE RIGHT TO TAKE PHOTOS, VIDEOS. & WRITE DOWN DETAILS

YOU CAN INFORM THE AGENT THAT YOU ARE GOING TO USE YOUR RIGHT TO RECORD. (YOU MUST NOT INTERFERE WITH THE AGENTS' DUTIES OR THE SAFETY OF OTHERS.)
