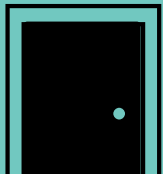


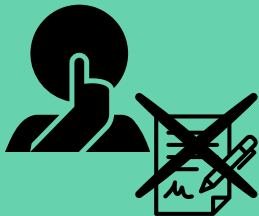
您的移民权利

移民与海关执法局（ICE）及海关与边境保护局（CBP）

您有权利不开门！



通过窗户或关着的门与执法人员沟通。
ICE和CBP执法人员必须持有法院签发并由法官签署的搜查令，
才能进入你的家。（参见背面示例）



您有权保持沉默，不要在任何文件上签字

您可以大声说出，
在没有律师在场的情况下您不会回答问题或在任何文件上签字。



您有权不同意无搜查令的搜查

您有权拒绝执法人员进入您的家。
您有权拒绝他们在没有搜查令的情况下搜查您的家、汽车或身体。



您有权拍照、录像并记下详细信息。

您可以告知执法人员您将行使录音录像的权利。
（您不得干扰执法人员的职责或他人的安全。）



向WAISN遣返热线报告此事。
